Key highlights include the groundbreaking for the much-anticipated Clubhouse, the opening of the new adult residential treatment program in Tampa, and CARF re-accreditation. The expansion of our system of care allows us to reach more individuals and families struggling with mental health and substance use disorders.



This four-year streak of success will not end here, as we have so much to look forward to next year. We will launch the ACTS Clubhouse for adults with mental illness and the Therapeutic Group Home for children with mental illness, expanding our array of services to support the needs of the community. With additional funding from the State, we will continue to increase the capacity of our adult residential services and medication assisted treatments. Due to enhancements in our recruitment and retention efforts, we also anticipate improvement in the workforce crisis that has impacted our programs for the past few years.

I would like to extend a special thank you to the Board of Directors and the entire ACTS Team. Their commitment to providing high quality services continues to have a positive impact on the communities we serve. This team has demonstrated resilience unlike any I have seen in my 31 years at ACTS. I am proud of the accomplishments of the past year and the goals we have set for next year. # Array of Services

## Crisis Care

Detoxification is the first step on the road to recovery. Our Detox Program for both adults and juveniles is the place to start the recovery process in a compassionate and supportive environment. Programs associated with Crisis Care include the Adult Addictions Receiving Facility and the Juvenile Addictions Receiving Facility.

## Outpatient Services

Outpatient Services accommodates individuals by allowing them to remain in their homes and be able to work or attend school while in treatment. Programs associated with Outpatient Services include Outpatient Detox, Outpatient Assessment, Medication Management, Medication Assisted Therapies, Intensive Outpatient Program and Traditional Outpatient Services.

## Residential Treatment

ACTS Residential Treatment Programs provide evidence-based treatment for substance use and co-occurring disorders for several months. Programs include Adult Residential Treatment Programs in Tarpon Springs and Tampa, two Intermediate Care Programs in Tampa and the Amethyst Respite Center in Tampa.

## Housing

ACTS Housing Division provides evidence-based housing intervention programs that combines affordable housing assistance with wraparound supportive services for individuals experiencing homelessness, as well as other individuals with disabilities. Programs include Permanent Supportive Housing, Community Support Services, Wraparound Housing and the HEART program in both Hillsborough and Polk Counties.

## Justice Services

ACTS has two full-service Juvenile Assessments Centers in Tampa and Bartow, an Early Offender Diversion Program for individuals diverted from prison and two jail diversion programs serving Hillsborough County.

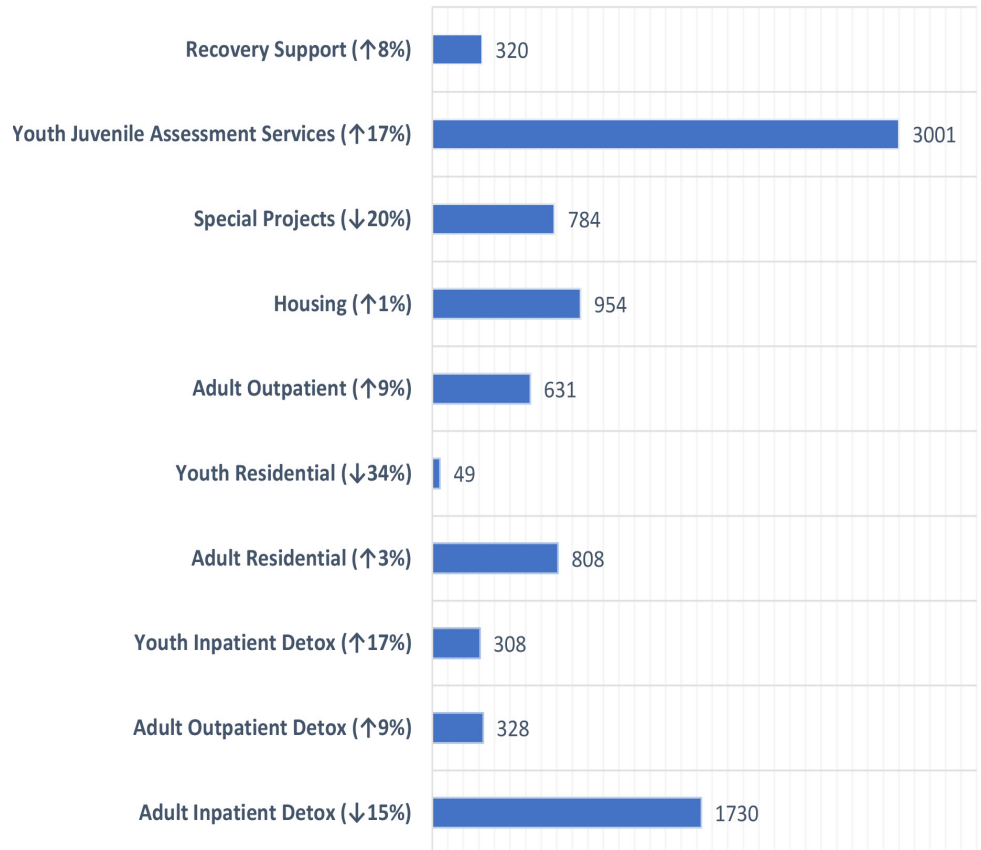

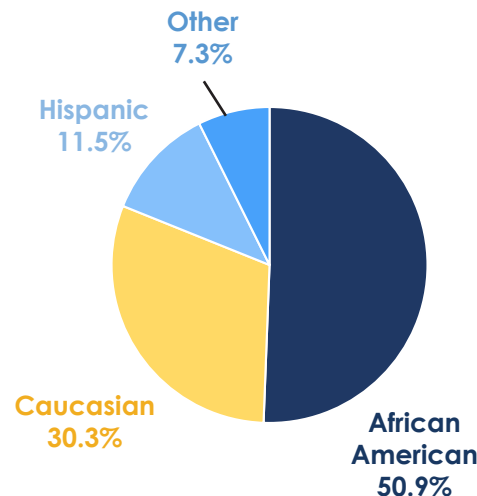

## Individuals Served By Service Line

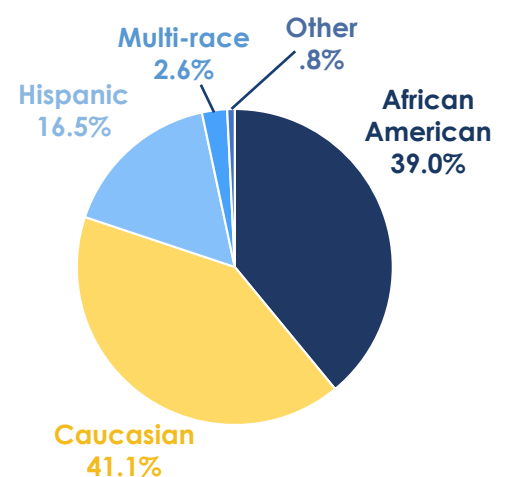
Arrow next to service denotes increase or decrease since previous fiscal year



## Ethnicity of Team Members

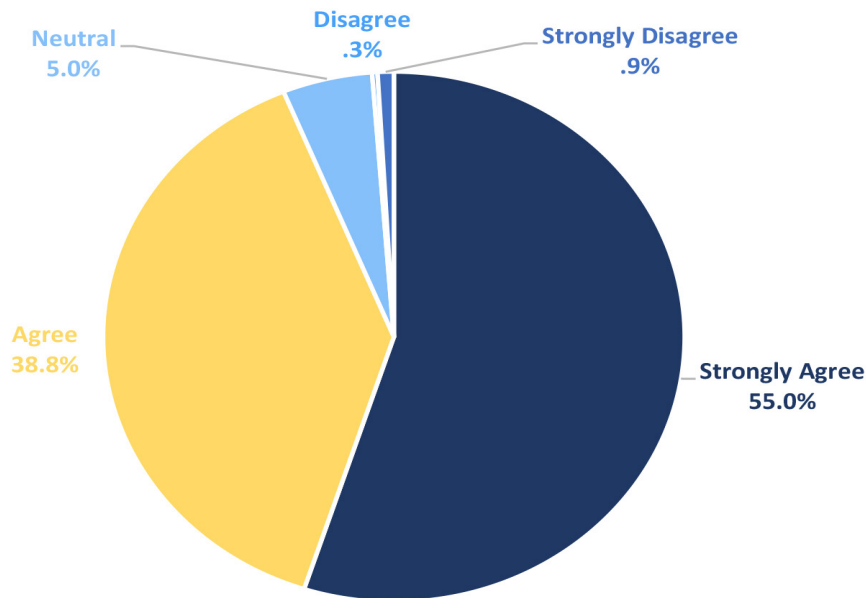


## Ethnicity of Persons Served

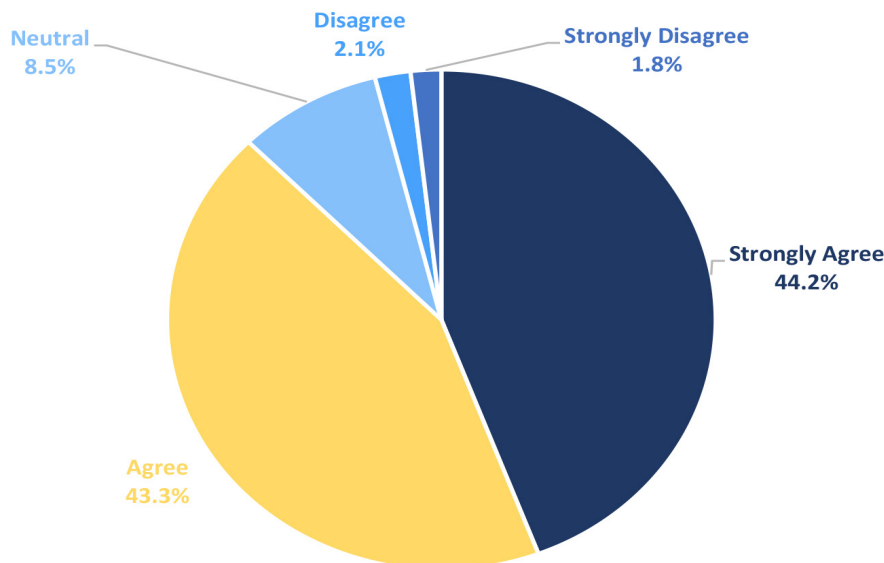
